

Florida Chamber Members and Friends,

Last fall, two months before the start of the 2018 Legislative Session, the Florida Chamber of Commerce put forward legislative recommendations designed to make Florida more competitive. The 2018 Jobs Agenda provided a road-map to continue strengthening Florida's economy, spur smart growth, and create quality jobs and economic opportunity for everyone.

Year after year, the Florida Chamber has been at the forefront of solving issues that impact Florida's business climate. We set off the 2018 Legislative Session with three priorities in mind: reducing the cost of living, reducing the cost of doing business and preparing for the future.

With only weeks remaining in the 60-day session, tragedy occurred, and rightfully so, lawmakers took steps to pass school safety measures. However, on the whole, lawmakers ultimately made it a bit more expensive for families and small businesses and a little less competitive for Florida job creators.

Recognizing that economic, political and demographic shifts have placed Florida in a fragile and changing position, it's vital that Florida's business community elect pro-jobs candidates to ensure unfinished business from this year's legislative session makes it across the finish line next session.

In November, voters will elect a new governor, and three other members of the Florida Cabinet, 120 members of the Florida House and 20 members to the Florida Senate. Our focus will continue to be on unifying Florida's business community to not only make sure the right things happen in Tallahassee and Washington, D.C., but that the right people are elected in order to keep those seeking to slow job creation out of office.

Every day, the Florida Chamber of Commerce unifies Florida's business community. Our focus, through smart policy, helping to elect pro-jobs candidates and forward-looking research, is to make Florida more competitive so Florida's job creators can create quality jobs, and economic prosperity for all.

Today, Florida's future remains our number one priority as we continue to be the state that others look to for leadership.

Consider the facts:

- ▶ We predict Florida will become a \$1 trillion economy in 2018,
- ▶ Florida is the third most populous state in the nation, and is expected to grow to 26 million people by 2030—that's 5 million more residents,
- ▶ Nearly 1 in 14 jobs in the United States are created in Florida,
- ▶ Voter turnout continues to increase with 75 percent of registered voters turning out to vote in the 2016 Presidential election cycle,
- ▶ Florida is second in the nation for 4-year public college affordability, and
- ▶ Unemployment rates continue to be lower than the national average, with Florida's unemployment rate at 3.9 percent as of February 2018.

**However, Florida stands on the precipice of a crisis once more.** Short-term politics instead of long-term economic prosperity, special interest agendas of environmental extremists, government unions, plaintiff trial lawyers and out-of-state billionaires with extreme agendas have made Florida's position more precarious than many leaders understand or want to admit.

Environmental extremists continue in their efforts to over-regulate Florida and disrupt smarter growth policies that protect the environment. By using sound science, we can prepare Florida for the water and energy needs associated with a growing population.

Government unions who think their interests come before the needs of Florida's students and workers are still trying to take options away from educators, families and employees.

Plaintiff trial lawyers continue to look for jackpot payouts at the expense of Florida's families and small businesses. From Florida's worsening lawsuit abuse problem to our workers' compensation crisis, Florida's business climate is at risk of becoming less competitive.



### FEDERAL ISSUES IMPACTING FLORIDA

#### Supporting Smarter Immigration Policy

The Florida Chamber supports a consistent federal policy for immigration that protects and compliments Florida's workforce and growing economy. Immigration reform allows Florida's international ties in trade to remain strong and provides a valuable population of skilled workers. With the recent announcement to end the Deferred Action for Childhood Arrivals (DACA) program, the Florida Chamber encourages Congress and the administration to work together to quickly find a legislative solution. **Without a legislative solution at least 800,000 DACA recipients will lose their ability to legally work and study**, leaving many Florida employers, workers and students without certainty.



The business community's premier legislative award, the Florida Chamber of Commerce's Most Valuable Legislator, goes to Senator Kathleen Passidomo, for her commitment to securing Florida's future.

Florida needs more public servants who wake up every day thinking about how to make Florida more competitive—regardless of the opponent or political consequences. A small businesswoman, Senator Passidomo has long been a fearless and effective partner in the Florida Chamber's fight for free enterprise. As the torch bearer of multiple Florida Chamber-backed priorities this session, she attracted bipartisan support for pro-jobs legislation, took well-funded special interests head on for Florida's future job creators, and successfully sought to keep Florida's dismal, bottom-five legal climate from getting worse.



Senator Passidomo understands that a world-class education is the greatest pathway toward economic opportunity. She took the lead on

championing Florida Chamber efforts to expand computer science and computer coding instruction throughout Florida's K-12 classrooms, knowing that nothing can better prepare Florida's students to enter a globally competitive workforce than the introduction of innovative STEM concepts during their formative years. Senator Passidomo was also a key ally in support of the targeted tax reform package that further reduced the Florida-only Business Rent Tax and provided back-to-school and hurricane preparation sales tax holidays.

Never afraid of a tough fight for what is right, Senator Passidomo also led the fight to ensure automobile insurance rates remain low for Floridians and opposed the trial lawyer's top legislative priority—repealing Florida's no-fault personal injury protection (PIP) insurance system without addressing bad faith reform. Even in the final days of session, Senator Passidomo stood ready to tackle bad faith and offer a common-sense solution to this Florida-only lawsuit abuse. 


