Local governments may regulate facilities' time, place and manner and, if state fails to timely act, may license facilities. Does not affect compassionate use of low-THC cannabis, nor immunize federal law violations.

Exempts and requires registration of assault weapons lawfully possessed prior to this provision's effective date. Creates criminal penalties for violations of this amendment.

Amendments lose petitions because signatures expire after two years if ballot position is not obtained. Once ballot position is assigned, signatures will not expire.

This amendment applies only to Florida law and state action, and does not immunize violations of federal law.
