As reported by the *Tampa Bay Times*, over 2,000 voters in the Tampa Bay region have changed their registration from Republican to NPA. lawsuits.



## Overwhelming Florida Voters Support COVID Liability Protections



## The United States Senate - Democratic Majority Democrats Win GA Battles

**The Big Picture:** Democrats claimed narrow victories in two US Senate runoff elections in Georgia on January 5<sup>th</sup>, gaining seats previously held by Republicans in both races. These were the last of the races to be decided in the battle for control of the Senate, and with them Democrats claimed control of the majority.

Senators-elect Jon Ossoff and Raphael Warnock (D-GA) will bring the Senate chamber's partisan divide to an even 50-50 for the 117<sup>th</sup> Congress. With Vice President-elect Kamala Harris as the tie-breaking vote when needed, Democrats complete the triumvirate of one-party control in Washington, having already held the US House and winning the Presidential race in November.

**By The Numbers:** The Democratic candidates Ossoff and Warnock were able to maintain high voter turnout amongst Black voters, helping propel their runoff wins. Despite having just half the total number of registered voters than Florida, Georgia has nearly 250,000 more Black voters than Florida. When looking at the entire electorate, 30% of registered voters in Georgia are Black compared to just 13% in Florida.

Why it Matters: For Florida's two Republican Senators this will put them into the minority for the first time since 2012 in the US Senate. It has a particular impact on Senator Scott, having recently been named Chair of the Republican Senate conference's 2022 election cycle efforts, as he now works to help Republicans regain the majority rather than defend it.

With unified government at the federal level, Democrats will be better able to pass their legislative agenda which has unanimous support within the party, though the very narrow majorities they hold in both chambers of Congress will imperil efforts with even the slightest disagreement within their caucuses. The Florida Chamber will remain observant of the impact any new legislation passed in Washington will have on the business community in Florida.
