🔀 Small & Local Business Taxes

Wants to increase taxes on small and local businesses by 40 percent, or \$1 billion, increasing costs and suppressing opportunity for Florida families.

Personal Income Taxes

Supports an agenda that would require a new 37 percent personal income tax or the equivalent of an increase of the sales tax to 39 percent.

Healthcare
