## Mainstreet Fairness, Unemployment Tax Relief and Business Rent Tax Reduction Headed to Governor

Thursday, the Florida House passed **SB 50** on a bipartisan vote of 93-24, before the Senate passed the bill 27-12, sending it to the Governor's desk. This bill is a huge win for Florida's business community and contains three significant priorities.

**SB 50**, as initially filed, created an economic nexus to collect sales taxes from internet retailers and marketplace providers. It has been a two-decade priority of the Florida Chamber to level the playing field between online retailers and out of state businesses doing business in the state and businesses located in the state that already collect and remit sales tax to the Department of Revenue. The US Supreme Court decision, Wayfair v. South Dakota, paved the way for states to set an economic nexus instead of just a physical presence nexus. Florida is only one of two states that collect a sales tax that has not adopted the Wayfair decision. This is not a new tax, but a tax that was already due, and simply shifts the collection point from the consumer to the business.



### Internet Sales Tax / Unemployment Compensation Trust Fund

Modernizes Florida's tax code and levels the playing field for main street businesses by allowing for the collection of sales tax from internet retailers. Florida and Missouri are the only two states in the country that have not adopted an economic nexus to collect online sales tax after the Wayfair Supreme Court decision. The bills deposit money into the unemployment compensation trust fund over the next several years to avoid the automatic \$713 million tax increase Florida employers were faced with this year and to help replenish the trust fund. After the trust fund is replenished, the bill provides for a business rent tax reduction from 5.5 percent to 2 percent.

**SB 50: Sen. Joe Gruters** Passed the Senate Floor, 27-12. Passed the House Floor, 93-24. Ready to head to the Governor's desk. HB 15: Rep. Chuck Clemons Substituted for SB 50.

### ICYMI: Florida Chamber's Matthew Choy Testified on HB 1507

Matthew Choy testified in support of HB 1507. This legislation, sponsored by Rep. Clay Yarborough, creates a state-wide system approach to improve the equity and access for all Floridians to have the opportunity to achieve economic self-sufficiency. The creation of the Office of Reimagining Education and Career Help will support the Florida Chamber Foundation's goal that at least 80% of Florida's workforce will have essential employability skills by 2030. ### <u>The Money Race</u> Legislature Considers More Constitutional Reforms to Limit Billionaire's Influence on Citizen Initiative Process

The Florida Legislature took action on two Florida Chamber-backed measures that will help protect our state's constitution. As you know, the Florida Constitution is one of the key reasons that Florida continues to spend within its means, protect the environment, and foster an excellent climate to live, work, and play.

The Florida Constitution also is known as one of the easiest state constitutions to amend, with 160 changes since adoption in 1968. Many of these changes could have been handled by statute which can more easily adjust to changing circumstances as knowledge improves, demographics change, or policy preferences shift. Some successful amendments were proposed and funded by a single wealthy individual – creating a worrying trend where one billionaire can buy their way onto a ballot through a process that was designed to be used by a ground swelling of broad support from the citizenry. The Florida Chamber of Commerce believes that reforms are needed to protect the Florida Constitution and bring further transparency to a process that currently lacks it. Fortunately, two measures are making their way through the process.

Senate Bill 1890, sponsored by Senator Ray Rodriguez, would cap donations to constitutional amendments in a similar way to candidates, ensuring that the citizen's initiative process reflects the will of the citizens plural, rather than just one individual. Recently, that bill was heard in Senate Ethics and Elections. Policy Director Christopher Emmanuel spoke in committee (watch the video here at 33:15) and the bill passed on party lines. The House companion is House Bill 699 by Representative Payne, which passed and was covered by statewide news.

The second measure is a joint resolution which would increase the threshold for constitutional passage from 60% to 66.6%. Those bills, House Joint Resolution 61 and Senate Joint Resolution 1238, each have one remaining committee stop. Because these measures are changing the Florida Constitution itself, they require supermajorities in both chambers and ultimately citizen approval, which would take place on the 2022 ballot.
